If you are an eligible worker, you may qualify for a training subsidy to help with the cost of your training.

The Construction Industry Training Board (CITB) provides access to subsidised training for apprentices, their employers and workers in the building and construction industry. If you are an eligible worker, you may qualify for a training subsidy to help with the cost of your training. If you don't currently hold a CITB Number please go to www.citb.org.au to apply for your CITB Number online. **Eligibility criteria apply.** 

## To claim the CITB eligible rate\* for a course you must:

- 1. Pay the full course fee at the time of enrolment, unless the course is delivered and assessed on the same day. Payment is by EFT, credit card or debit card.
- 2. Provide your **valid CITB Number** at the time of enrolment. Please CHECK your CITB number is current and valid. You MUST have a valid CITB Number before the course commencement date. If not, you cannot claim the CITB rebate from us.
- 3. The CITB Number provided must be yours you cannot use another person's or company's CITB Number. (We encourage you to visit the CITB website <a href="www.citb.org.au">www.citb.org.au</a> to verify your details)
- 4. You MUST fill out our CITB claim form and lodge it with your enrolment a separate claim form is required for each individual CITB-eligible course undertaken.
- 5. To receive the CITB rebate your assessments must have been submitted and deemed competent (i.e. you must "pass" the course) within 60 calendar days# after the assessment submission date advertised for the course.
- 6. At your <u>successful completion</u> of a CITB eligible course, eligible CITB students who have completed all of the above steps will be refunded the relevant CITB fee subsidy. <u>Refunds will be made to the party who</u> paid the course fee upon enrolment within 28 days if the certificate being issued.

\*Please note: if you submit a course assessment outside the 60-calendar day period, the rebate amount may be forfeited.

\*CITB prices shown for our courses are subject to change without notice. The subsidy is levelled against the course fee and is not applied to any course materials you purchase separately for your course e.g. text books.
